This case has been assigned to the calendar of United States District Judge Otis D. Wright II. The responsibility for the progress of litigation in the federal courts falls not only upon the attorneys in the action, but upon the court as well.

In order "to secure the just, speedy, and inexpensive determination of every action," Fed. R. Civ. P. 1, all counsel are hereby ordered to familiarize themselves with the Federal Rules of Civil Procedure and the Local Rules of the Central District of California.

Counsel please note the changes made to former Local Rule 6, now superseded by 1 Federal Rules of Civil Procedure 16 and 26(f), effective December 1, 2000. A 2 Scheduling Conference is set for the date and time set forth in the caption.<sup>1</sup> 3 Counsel shall meet at least 21 days in advance of the Scheduling Conference to 4 prepare a jointly signed report for the court to be submitted no less than 7 days 5 before the Scheduling Conference. See Fed. R. Civ. P. 26(f)(1)-(2). The report is 6 to contain the items set forth below. Pursuant to Rule 16(c), the parties shall be 7 represented by counsel with authority to enter into stipulations regarding all 8 matters pertaining to conduct of the case. 9

The joint report to be submitted shall contain the items listed in Rule 26(f), the parties' recommendations and agreements, if any, about the final scheduling order as listed in Rule 16(b)(1) through (6), and those items listed in Rule 16(c) which counsel believe will be useful to discuss at the Scheduling Conference. Items which must be listed are the following:

15	(1)	a listing and proposed schedule of written discovery, depositions, and a proposed
16		discovery cut-off date;
17	(2)	a listing and proposed schedule of law and motion matters, and a proposed dispositive
18		motion cut-off date;
19	(3)	a statement of what efforts have been made to settle or resolve the case to date and what
20		settlement procedure is recommended pursuant to Local Rule 16-15.4 (specifically
21		excluding any statement of the terms discussed);

or all discovery is premature, it is advisable for counsel to begin to conduct discovery actively
before the Scheduling Conference required by Rule 16(b). At the very least, the parties shall
comply fully with the letter and spirit of Rule 26(a) and thereby obtain and produce most of what
would be produced in the early stage of discovery, because at the Scheduling Conference the
Court will impose tight deadlines to complete discovery.

A continuance of the Scheduling Conference will be granted only for good 1 cause. (Counsel are informed that continuance of the Scheduling Conference causes commensurate delay in the trial date.) The failure to submit a joint report in advance of the Scheduling Conference or the failure to attend the Scheduling Conference may result in the dismissal of the action, striking the answer and entering a default, or the imposition of sanctions.

A settlement procedure appropriate to the particular case will be used in every civil action pursuant to Local Rule 16-15.1. In the Scheduling Conference Report, counsel are to recommend a specific settlement procedure provided for in Local Rule 16-15 which will be utilized in this case. Available alternatives for consideration, not to the exclusion of others, include:

25	sanctions under Rule16(f) against the party or parties responsible. No courtesy			
26	copies of the Joint Report are required.

motion date can be found on the Court's motion calendar, which can be viewed on 2 the Court's website.<sup>4</sup> This Court hears motions on **Mondays**, commencing at 3 **1:30 p.m.** No supplemental brief shall be filed without prior leave of Court. 4 Courtesy copies are not required, except for motions for summary judgment or 5 motions involving a substantial evidentiary showing. For these motions only, 6 conformed courtesy copies of moving, opposition, and reply papers shall be 7 delivered to the courtesy box on the 4th FLOOR of the U.S. Courthouse, 350 W. 8 1st Street, by the following business day. Courtesy copies shall NOT be blue-9 backed. Adherence to the timing requirements is mandatory for chambers' 10 preparation of motion matters. 11 Counsel should take note of the changes to the Local Rules affecting motion 12 practice in the Central District. Among other things, Local Rule 7-3 requires 13 counsel to engage in a pre-filing conference "to discuss thoroughly . . . the 14 substance of the contemplated motion and any potential resolution." Counsel 15 should discuss the issues sufficiently that if a motion is still necessary, the briefing 16 may be directed to those substantive issues requiring resolution by the Court. 17 Counsel should resolve minor procedural or other nonsubstantive matters during 18 the conference. 19 20

Memoranda of Points and Authorities in support of or in opposition to motions shall not exceed 7,000 words. C.D. Cal. Civ. L.R. 11-6.1. Replies shall not exceed 3,300 words. Only in rare instances and for good cause shown will the Court grant an application to extend these limitations. Typeface shall comply with Local Rule 11-3.1.1. NOTE: Times New Roman font must be used and the size must be no less than 14. Footnotes shall be in typeface no less than two

Motions shall be filed in accordance with Local Rule 7; the next available

sizes smaller than text size and shall be used sparingly. Filings that do not conform to the Local Rules and this Order will not be considered.

Each party filing or opposing a motion or seeking the determination of any matter shall serve and lodge a Proposed Order setting forth the relief or action sought and a brief statement of the rationale for the decision with appropriate citations.

Counsel are reminded ex parte applications are solely for extraordinary relief. *See Mission Power Engineering Co. v. Continental Casualty Co.*, 883 F. Supp. 488 (C.D. Cal. 1995).

Counsel for plaintiff shall immediately serve this Order on all parties who have not yet appeared in this matter, including any new parties later added to the action.
