THE APPOINTMENT OF THE MERIT SELECTION PANEL

(Amends General Order No. 14-07)

Pursuant to 28 U.S.C. § 631(b)(5) and the relevant standards and procedures promulgated by the Judicial Conference of the United States, the Court must appoint a Merit Selection Panel to assist the Court with the appointment and reappointment of magistrate judges. The Court's current Merit Selection Panel was appointed on October 21, 2013, by General Order No. 13-12. On December 15, 2014, the Court appointed one new member, a new Chair and Vice Chair, and reappointed Panel members whose terms were set to expire on December 31, 2014. It is now necessary to replace two members.

IT IS THEREFORE ORDERED that the following individuals be, and hereby are, appointed to the Court's Merit Selection Panel for a three-year term ending December 31, 2017: James Newton to replace non-attorney member David Waterhouse; and Daniel Roberts to replace John Porter. Mr. Newton and Mr. Roberts shall be eligible for reappointment to the Merit Selection Panel for one additional term of three years, at the discretion of the Court.

The Merit Selection Panel's full membership is set forth in Attachment A to this General Order. This General Order shall become effective upon filing by the Clerk of this Court.
