WHEREAS, the Court has adopted gating criteria designed to assess local COVID-19 exposure risks based on 14-day trends of facility exposure, community spread, and community restrictions;

WHEREAS, the Court has delegated authority to the Executive Committee to determine when the Court should transition between phases of the Court's Reopening Plan per the gating criteria; and

,	WHEREAS, per the gating criteria, local COVID-19 exposure risks in the		
	Court's Southern Division are decreasing, such that the transition of the Southern		
)	Division to Phase 3 of the Court's Reopening Plan is appropriate at this time;		
	Upon unanimous vote of the Executive Committee, and without objection from
