15	promulgated by the Judicial Conference of the United States, the court must appoint a	
16	Merit Selection Panel to assist the court with the appointment and reappointment of

18	December 13, 2011, by General Order No. 11-17. However, pursuant to that General	
19	Order, the terms of certain Panel members are due to expire at the end of 2013.	
20	IT IS THEREFORE ORDERED that each of the following individuals be, and	
21	hereby is, reappointed to the court's Merit Selection Panel for one three-year term	
22	beginning January 1, 2014: Ingrid V. Eagly, John C. Hueston, Peter J. Most,	
23	Dominique R. Shelton, Mona C. Soo Hoo, Lawrence B. Steinberg, Theresa M. Traber,	
24	and Helen E. Zukin. None of these individuals shall be eligible for immediate	
25	reappointment to the Merit Selection Panel upon the expiration of this term.	
26	IT IS FURTHER ORDERED that the following individual be, and hereby is,

appointed to the court's Merit Selection Panel for a three-year term beginning January 27 1, 2014: Milli Borgarding. Ms. Borgarding shall be eligible for reappointment to the 28

1 Merit Selection Panel for one additional term of three years, at the discretion of the
2 court.

IT IS FURTHER ORDERED that Brian Currey shall serve as Chair of the Merit
Selection Panel for a term of one year, beginning January 1, 2014, and that Martha K.
Gooding shall serve as Vice Chair of the Panel for the same term. The court
anticipates that, at the end of this term, either the Chair and Vice Chair will be
reappointed to serve an additional term, or Martha K. Gooding will be appointed Chair
of the Merit Selection Panel, and a new Vice Chair will be appointed.

9 IT IS FURTHER ORDERED that the Merit Selection Panel whose full
 10 membership is set forth in Attachment A to this General Order is hereby appointed to

 12 Central District of California during the term of this Merit Selection Panel.
