GENERAL ORDER NO. 194

PART ONE

IT IS HEREBY ORDERED that the following duties are assigned to the full-time Magistrates:

I. CIVIL MATTERS

III. ADMINISTRATIVE MATTERS

The Presiding Magistrate shall administer the Central Violations Bureau and recommend amendments to the bail schedule. (Rule 2.18)

PART TWO

IT IS FURTHER ORDERED that the following duties are assigned to the part-time Magistrates in cases arising in their respective locations:

I. CIVIL MATTERS

- A. Conduct proceedings for the collection of civil penalties of not more than \$200 assessed under the Federal Boat Safety Act of 1971, in accordance with 46 U.S.C. §1484(d); upon transfer of the case as provided in Rule 3.4.04. (Rule 7.1.01)
- B. Conduct examinations of judgment debtors in accordance with Rule 69 of the Federal Rules of Civil Procedure if the judgment debtor sought to be examined resides or has a place of business in excess of 150 miles from the United States Courthouse in Los Angeles.

- C. Petition for Discharge of Indigent Prisoners. (Rule 7.1.0

Each of the part-time United States Magistrates shall perform all of the duties and functions previously performed by United States Commissioners and the following additional duties:

- C. Conduct initial appearance proceedings. (Rule 7.2.03)
- D. Conduct preliminary examinations. (Rule 7.2.04)
- E. Administer oaths, set bail, and approve sureties. (Rule 7.2.05)
- F. Set bail for material witnesses. (Rule 7.2.06)
- G. Conduct proceedings re holding to security of the peace and for good behavior. (Rule 7.2.07)
- H. Conduct removal proceedings. (Rule 7.2.08)
- I. Try petty and minor offenses as specified in 18 U.S.C. §3401. (Rule 7.2.9)

this Order, General Orders 104 through 104-F inclusive are hereby revoked with the following exceptions: The provisions of General Order 104, Part II, relating to Arraignments and Pleas, Division of Functions Between Magistrates and the Court, and creation of the Criminal Duty Judge, and General Order 104-E, relating to the assignment of subsequent cases pursuant to Rule 20, shall remain in full force and effect as to all provisions which do not conflict with this Order.

IT IS FURTHER ORDERED that the effective date of this Order shall be July -1, 1979.
